All members who plan to have their animals in the market sale have educational meeting and YQCA certification

requirements. You <u>must</u> attend one of the countywide project meetings/clinics in each livestock project you are enrolled in or another approved educational meeting in the state or region. All livestock members must be <u>YQCA certified by July 6</u> (this does not count as an educational meeting). UW-Extension will verify all YQCA certified members. See enclosed sheet with guidelines.

If you attend an out-of-county educational meeting, you must have a completed Project Meeting Attendance Verification Form and submit to the Outagamie County Extension office. You can find this form at https://outagamie.extension.wisc.edu go to 4-H Youth/Project Opportunities/Livestock.

Animal ID (Rate-of-Gain has been eliminated for all species) There will be no weigh-ins for beef, sheep, swine, and goats for 2020. All Livestock exhibitors must have their animal tags picked up and put in the animal's ear by April 15. If animals are not tagged by April 15 they are not in the market project. Tags will be available at YQCA and educational meetings prior to April 15. Cost of ear tags will be \$1/tag for sheep, goats, beef, and \$2 for swine.

Livestock Fitting & Showing Clinics, Seymour Fairgrounds: Your county youth livestock committee will be planning fitting and showing clinics. Dates are: Goats - June 13, 10 a.m.; Sheep - June 16, 7 p.m.; Swine - June 23, 7 p.m.; Beef – June 25, 7 p.m. The clinics will give you additional assistance in preparing your animal(s) for the county fair in July. Watch for updates in the 4-H family newsletters.

<u>2020 Area Animal Science Day – June 12, Marathon County</u>: This is an event where youth in the beef, dairy, horse, sheep and swine projects increase their skills and knowledge of animals through judging and grading experiences. Events include evaluation of dairy cattle, horses and meat animals; dairy showmanship contests; hippology (study of horses); and oral reasons workshops. In addition, each site may offer a variety of workshops for small animal projects, which may include rabbits, poultry, and dogs.

Animal Fee 2020: The Outagamie County Fair Board will be implementing Animal Fees for all Open and 4-H animal species exhibits housed during the fair. Payment will be required with the animal entries by the normal entry deadline. There will be no refunds for animal exhibits entered, but not brought to the fair.

<u>Drug History</u>: All exhibitors must have a market animal drug history form per species of animal per exhibitor upon arrival at the county fair to weigh in animals. A form is enclosed in this mailing. Please keep this form in your files until county fair.

County Youth Livestock Sale: The sale will be Friday, July 24, 5:30 p.m. All prerequisites for the sale are enclosed in this communication. Please keep this letter so that you understand the necessary requirements.

Annual Meat Processing
Contest: During October we will be having the annual meat processing contest.
Participants will have the opportunity to learn about and participate in making brats. All 4-H youth (grades 3-12) and FFA youth are eligible to participate. More information on dates and location will be coming.

Scholarship Opportunity: United Veterinary Service will once again be offering a \$1000.00 scholarship to a graduating senior this spring. Half of the scholarship, \$500, is for the first year of college or technical school, and the second half, \$500, is paid for the second year of studies. The scholarship application is available to any student in Waupaca, Shawano, Outagamie, Waushara or Winnebago counties who was enrolled in a supervised animal project in 4-H, FFA or Scouting. There are no restrictions regarding the area of study the student pursues.

Wisconsin State Fair and Other National Exhibitions will require certification in YQCA for 2020 events.

Wisconsin State Fair's process for 2020 840 RFID ear tag and DNA identification is as follows: 840 RFID Ear Tag and DNA Identification Submission Due Date: All Wisconsin State Fair 840 RFID ear tag and DNA identification requirements for Junior Show Beef, Sheep, and Swine (market and non-registered breeding stock) All DNA samples must be returned to Wisconsin State Fair (Wisconsin State Fair, Agriculture Department, 640 S 84th St, West Allis WI 53214) on or before May 21.

840 Ear Tag Identification: Wisconsin State Fair requires an official 840 RFID ear tag for identification. 840 RFID ear tags are available to purchase from Wisconsin State Fair BUT DO NOT need to be purchased through Wisconsin State Fair. Any official 840 RFID ear tag is accepted. The 15-digit number sequence on the 840 RFID ear tag will be the recognized number for individual animal identification.

DNA Identification: DNA hair kits will be available for purchase online from Wisconsin State Fair by credit card only. DNA sales open soon.

Purchasing and submission of 840 RFID ear tags and/or DNA kits is NOT entry in the 2020 Wisconsin State Fair Junior Show. Exhibitors MUST enter the Wisconsin State Fair Junior Show online at wistatefair.com in a separate process.

2020 Wisconsin State Fair Entry Deadlines:

- May 21, 2020: YQCA Certification Deadline
- May 21, 2020 7 pm (Central Time): Online entries and Youth Center Reservations close at regular fees
- May 28, 2020 5 pm (Central Time): Late online entries with late fees close

Junior exhibitors will submit all entry information and fees directly to State Fair either online or via the mail. Local County Extension Office/4-H Leaders will still be informed of State Fair youth programs but will not be involved in the entry process. Participation is open to any boy or girl 12-19 years of age as of January 1st of the current year. Junior exhibitors must be an active/participating member in good standing with an approved adult-supervised Wisconsin animal based youth organization by March 1st of the current year to be eligible to participate in Junior Fair programs.
